## **About Scott Peterson:**

Scott started riding in 1972 and quickly earned his way through the U.S. Pony Club ranks. He rode his first Prix St. George in 1976 and competed at Dressage at Devon. Turning professional in 1978, he operated his own stable in the Detroit area before moving South Carolina in 1983. There he operated a large stable for five years where he usually had eight horses in training and taught over 200 lessons per month.

In 1989, after marrying his wife, Katie, they built and operated OneWood Farm for twenty-two years. Scott and Katie and their students competed throughout the southeast and spent their winters living, training and competing in Wellington, Florida.

In 1996 Scott and his family moved with horses to The Netherlands for a year to live and train with Anky VanGrunsven and Sjef Janssen daily. Prior to working with Sjef and Anky, Scott had many mentors including Robert Dover, Violet Hopkins, Hubert Rohrer, Chuck Grant, and David Lackey.

Over the years Scott has trained many riders and horses through the FEI levels. He trained a horse and rider combination to the team gold medal win at the North American Young Riders Championship in 2000, he and his wife, Katie, both earned their USDF gold medals, and they competed in numerous CDI's with many successful placing's. In 2007 he helped coach the University of South Carolina Women's Equestrian team to the National Varsity Championship.

Scott has been a USEF Dressage judge for over 30 years, he holds an 'S' rating and he judges all over the country. He has judged many regional championships and judged the US Dressage Finals in Lexington Kentucky in 2017. In March of 2019 Scott and Katie bought a 17.2 hand, six-year-old Dutch Warmblood named Royal Jester, (Jester) and Scott rides and trains him daily.

He currently lives on Keuka Lake in Penn Yan, New York with his family and travels to do clinics and lessons. He says his biggest riding accomplishment is, "After teaching my wife on three or four horses a day, every day for twenty-two years, we are still married!"

**ENTRIES:** Symposium registration for riders is first come, first serve. 8 rides available per day. CNYD&CTA will utilize the online clinic entry system via the Cognito form. If clinic cancels, riders will receive refunds minus PayPal fees. A waiting list will be established if a significant number of applications are received.

**ATTIRE:** Clinic attire is requested (boots, breeches or jodhpurs, gloves, collared shirt). ASTM/ SEI approved helmet is required.

**VACCINATION REQUIREMENTS:** As of April 21, 2021, CNYD&CTA now requires proof of the following equine vaccinations, within 6 months, to be submitted with all clinic and horse show entries: Equine Influenza, Equine Herpes Virus (Rhinoneumonitis), Rabies, and proof of negative Coggins.
