Financial Report: treasurer not in attendance

Membership reports: There are 40 paid up members with 4 new members for 2015. There are 17 members from 2014 who have not as yet renewed. Donna has sent out reminder emails to them.

Jr/Young Rider Committee Report: The committee is open to any ideas that club members might have. Possibly the club could: sponsor a class at the schooling show; have a freestyle class with costumes; offer prix caprilli jumping classes; have a visiting student program; get young riders prepared for Lendon Gray's Dressage for Kids; or provide a kids camp/clinic of our own. There should be some outreach to the local pony clubs, 4H clubs and other groups be they hunter/jumper, western, eventing, or high school/ college programs, that are catering to young riders. The consensus was that, to encourage participation in dressage, the camaraderie with others of similar age is a must.

June 27/28 Schooling show/ USDF Recognized Show: Pam Wooding, our "S" level judge, has been in contact and she likes the format of the schooling show on Sat. We have Leonie Fernandez as the "r" judge for the weekend as well as Camille Kopsick as TD. Finger Lakes Equine Practice will be the vet on call and Darlene Callahan has generously agreed to do the show program once again. Mention was made that last year the walkie talkies were not provided by the sound system supplier. We need to be sure to get them this year. The tent company has been contacted and a tent reserved.

The question of the arena flowers came up and it was decided that fake flowers were probably a good alternative. J-M Law mentioned that she had seen some very inexpensive flower box / letter holders made out of PVC pipe. She will look into the design and we can hopefully find a handy member who can put these together for us.

Casual Show: Marie Josee DeLisle has been hired as judge for the August 15th Casual Show at Oxley Equestrian Center. She has also agreed to do some teaching at either end of the show or possibly just on one of the days. She will teach 8 lessons per day on the clinic days. Her fee for teaching will need to be determined. Cornell may give us a good rate for the two/three day event.

Education Clinic: The biomechanics clinic proposal was once again discussed and found to be too expensive. The clinic with Marie Josee DeLisle may serve as the clinic/camp alternative for this year.

A braiding 'hands on' clinic is proposed for a smaller activity that everyone can get involved in. The clinic will possibly be held at Mary Reynolds Farm where some members are boarding. It will likely be held mid week and will feature the raffling off of a braiding kit. A dish to pass barbeque will be organized for this meeting.

New Business: There was some talk of organizing a list of stables that have cross country courses that would be available for use. The club might then have a trailer in day so members could school their horses over the jumps.

Equine Karma

When did I start to be horse crazy? Some time before the age of 12. Growing up in New York City, I would save my allowance for a monthly riding lesson, and when I started working, all the extra money went into a jar for tall boots. I was lucky enough to go to Wishe Riding Camp for three years, followed by another five years of working at the camp. In college, I started an Intercollegiate Horse Show Association team, and one of the benefits was being allowed to ride a really rank little palomino that no one else wanted to ride. That was fine with me, as it was free!

When I met the guy who was to become my husband, I made it clear that horses had to be in my life, and when we bought our property, it had to have space for a horse. It did - three and a half acres, and a chicken shed that someone had converted to a goat barn. Surely we could make it fit a horse?

I had a very limited budget when I began my quest. The horses in my price range were pretty pathetic, and not at all suitable for what I had in mind. Then, I found Buttercup. At 14-3, she was small, but I'm short, so no big problem; and she would fit into the barn! I felt an immediate rapport with the sellers. Their daughter, Judy, had gone off to school, the husband had lost interest in riding without the daughter around, and so Buttercup needed to find a new home. She was a 12 year old grade buckskin quarter horse. My best friend boarded her while we finished a stall for her in the converted goat/chicken barn. I hacked her home a few weeks later - it was one of the happiest days of my life!

Buttercup and I did everything - we went fox hunting, where she was not at all content to stay at the rear of the pack with the guests. We went on trail rides and we went to local hunter shows. We evented through Novice level, placing so consistently that I knew it was time to move on to Training level. At that point she was 17, and I decided to retire her sound, rather than compete at the higher level. She went on to give my young son his first rides, and to give my 80+ year old father his last. Dad had said, "I just want to see the world from the back of a horse one last time". All he did was sit on Buttercup as she stood still as a statue; that was enough.

After Buttercup came a succession of more or less (mostly less) successful equine partners. Moon was a 3 year old thoroughbred rescued from the necropsy line at Cornell. We did fabulously in dressage and eventing for a couple of years, until he lost a screw in his brain, and had to be euthanized. Becky was another thoroughbred that I lost to a raging case of uveitis. Selby was a wonderful little Morgan. When I got him, he was 9 years old, going on three. When I sold him, he was nineteen, going on four.

At that point, I decided I was going to buy what I had always wanted - an Appendix Quarter horse. These were the horses we had at camp, and I had always loved the combination. It took me a year and a half, but I found my dream horse. At five, Quincy was schooling at the 2-6 hunter level, but I was convinced I could and would make him into a dressage horse. My eventing years were behind me, lost to age and waning confidence, but I still wanted the challenge of training and competing in dressage.

Quincy did give me the challenge I was seeking. He had the wrong conformation for dressage - butt high, low set neck, thick throat latch. I had always believed that dressage allowed you to bring out the best in any horse, no matter what the breed or conformation, and this is what kept me going. He also had a stubborn streak. I remember taking a clinic with Thomas Ritter, a German "Bereiter". I couldn't get Quincy to do what he wanted, so he asked me to dismount, and he would work with the horse in hand. Thomas stands over 6 feet, and Quincy is 15-3, but it took 45 minutes of resistance before Quincy decided to do what was being asked.

Over the years, we did graduate to First Level. We never did spectacularly, and sometimes we embarrassed ourselves, but we kept going. As I reached my 60th birthday, I decided that Quincy had gone as far as he was happy in the dressage arena, and I should find a more suitable partner, and find Quincy a more suitable home. I purchased a horse with some training, and listed Quincy on line.

It took me a year and a half to find him, and nearly as long to find his new person. Of all the people in the horse world, Buttercup's former owner, Judy, has become Quincy's new person.

Over the years, I had met up with Judy's mom - their farm name was unique, and it was also on their license plate, so I had recognized it in a parking lot, and chatted with mom a bit. Then, last December, on the anniversary of Buttercup's death, I had run into Judy at a tack shop. We didn't realize the connection until we had chatted a bit. We traded contact information, but then the holidays came and we lost touch.

As our early spring made it's appearance there was increasing interest in Quincy. Several teens came to try him out, but he wasn't perfect for any of them, and I worried that if a young person took him, they would lose interest in a few years, and he could end up in a bad place. Several "older" riders (younger than I am!) called, but were intimidated because he is not bombproof. (is any horse?). Then I got an e-mail from Judy. She really didn't want to come look, because he was priced above her budget. But she felt that he was worth looking at anyway.

Judy came on one of the few days that we had snow, and as it slid off the roof, Quincy took her on an unexpected trip halfway across the arena. She looked a bit green, but decided there was enough to like about the horse that she would come back after all the snow was gone - the next day. She was in love. I felt this was such a good match, and the karmic connection with Buttercup could not be overlooked. I lowered the price, and we signed the paperwork.

General Information

GAIG/USDF QUALIFYING - GAIG/USDF Qualifying Classes, rider and owner must be a USEF member (Junior, Senior or Life); horse must be lifetime registered/recorded with USDF and USEF, rider must be an USDF participating member, and owner must be a USDF participating or business member.

FREESTYLE CLASSES – Copy of your qualifying test score must be included with entry.

OPPORTUNITY CLASSES – No memberships or federation fees required for participant or horse unless riding in other recognized classes.

AWARDS - First place prize awarded and ribbons to 6th place. Championship and Reserve Championship will be awarded at each level with 3 or more riders

FOOTING & ARENAS - Competition arenas and warm up areas are blue stone. Training Level tests may be ridden in a small arena; all other tests will be ridden in a large arena.

REQUIRED DOCUMENTATION - USDF Horse ID or Horse Lifetime Registration number is required. Include copies of your USDF Horse Registration or HID card. If you do not have a USDF HID or Registration, you will be required to buy either a USDF Lifetime Horse ID or Lifetime Horse Registration. If you have a USDF HID or Lifetime Registration number but cannot provide proof, you will be required to fill out a USDF affidavit and pay an additional \$5.00 fee before you are allowed to compete.

ENTRIES: Entry forms can be found at www.cayugaDressage.org. New for 2015, this show will accept online entries and payment via Equestrian Entries at www.equestrianentries.com. Entries will not be accepted without a copy of Negative Coggins Test valid within two years of the show and a copy of a Rabies certificate (signed by a veterinarian, valid within one year of competition date). You MUST include copies of your USEF membership cards, proof of USDF membership or non-member ID, USDF Horse ID/Registration, and if GAIG/USDF Qualifying, USEF Lifetime Horse Recording, a completed and signed entry form, and all fees. Incomplete entries, i.e., those missing required documents will be charged \$10. Class changes after the closing date will cost \$10.00 per change.

REFUNDS: Refunds will be given for cancellations received in writing before the closing date less a \$20.00 office fee. If for any reason a class(es) or an entire day(s) needs to be canceled due to an act of God, national tragedy, or any other reason, no refunds will be made. Refunds after Closing Date ONLY with documented proof from a Medical or Veterinary doctor showing cause as to why the competitor should be excused.

POST ENTRIES will be accepted on a first-come, first-served basis if space is available. Classes entered after the closing date will cost an additional \$10.00 per class. Incomplete entries, i.e., those missing required documents will be charged \$10.

PAYMENT: MAKE CHECKS PAYABLE to: Cayuga Dressage & Combined Training, Inc. and mail with entry form to the Secretary. Checks with insufficient funds will be accessed at \$30 service fee.

TIMES Tentative times may be obtained via the Internet. www.FoxVillage.com. Times will be available 3 days before the show. If you do not have access to the Internet, contact the Show Secretary to obtain your times.

STABLING - Permanent wooden stalls 10' x 10' w/full doors for horses and tack (subject to availability) are available on the grounds. Bedding is not provided but available to buy. Show horses have stabling preference over non-compete horses. **CAMPING** on-site, \$30/night/site. Hook-ups available.

SERVICES: EMT will be on the grounds during the show; a farrier will be on the grounds during the show and veterinarian (posted at show office) will be on call.




