FROM CDCT'S PRESIDENT:

People who have invested their time and energy and affections into an activity for a long time feel concern that the hard learned lessons of the past will be forgotten, threatening the very body they care about. Often, this is even truer in cases where volunteers have done the labor, for people volunteer for the things they truly love, and often do not feel the same sense of attachment to a "day job." Long timers get tired and want to hand things over, and yet things come to an unspoken lull of enthusiasm. New recruits feel that they cannot find a place to try out their ideas, for fear they will be encroaching on the hard work of the past. The words, "the way we always did it" out of one mouth, intended as friendly advice, can be heard as discouragement to a newcomer.

I believe CDCT faces just such a challenge right now. The club has a good reputation in our region as one providing excellent programming and valuable, unique contributions to the equestrian community. These people know the value of the club, are loathe to watch it wither, and yet want to have the luxury of attending events with their horses as participants and not merely (or also) as the ground crew. This situation is not unique to our club, nor is it uncommon or even unstudied. It is part and parcel of successful organizations facing the transition of generational succession. There are solutions to this kind of situation, and we need to embrace these solutions. We also need, in everything we do, to start planning for succession of our activities.


To this end, I would like to propose that we create a new tier of leadership in our club, one which allows us to honor and benefit from the long term memory and experience of the club's founders and older members. I would like to propose that we create what can be called "A Council of Elders." The people who would form this tier would be the following: 1) People who were founding members of the club when it started in the 1970's; 2) Anyone who has served as president of the club in the past; 3) Anyone who has served as an officer in any capacity for more than ten years total; 3) Anyone who has been a member of the club for more than twenty years. The people fitting into this category will be overlapping.

The role of the Council of Elders would be to enjoy the fruits of their own legacy in the club, and be on hand for advice and providing a sense of the history of the club to new people taking the reins. I would urge us to create a venue, perhaps an annual dinner in their honor, where we can enjoy the long history of our club and benefit from this stabilizing effect of so many older people with experience.

I hope in the year of 2018, we can make the issue of succession a central theme of all we do. From my end, I will be working to help organize, publicize and if necessary create documentation on all club

activities that can be handed over at a moment's notice to anyone taking over that activity. I hope we can also welcome the new faces showing an interest in our club. Many of the older members of this club started as they start now: new to dressage, with horses they have and love who may not be purpose bred for our sport, and excited to see what this kind of classical training can do for their equine partners.

There is so much to celebrate in the legacy left to our club by our founders and long time members. Let's honor that as we create the space for the next generation. I hope in 2078, some group of horse lovers will be celebrating the centennial of our club, and some council of leaders, perhaps not even born yet, will be there to usher in a second century of CDCT. In history, as now, the hardworking elders of our club will look like the selfless and tireless people we know them to be. WE owe them a debt of deep gratitude.

MEMBER BIO: CAROLINE MCCONNELL JUNIOR/YOUNG RIDER

I was three when my mother took me to a pony ride farm and I repeatedly begged to go around, again and again, my mother decided riding lessons would be cheaper. I started riding at the age of four and a half at local hunter/jumper barns but decided to make the switch to dressage in 2009 and haven't looked back! Since I began riding dressage I have ridden Training Level through the Prix St George receiving both the USDF Bronze and Silver Medals. In that span of 7 years I have competed in The USDF Dressage Seat Medal Finals in Estes Park, Colorado and The USDF Festival of Champions in Gladstone, New Jersey, ridden under Lendon Gray, Courtney King-Dye, Heather Mason, and Scott Hassler, to name a few, and have been selected to participate in 3 years of Lendon Gray's highly esteemed Winter Intensive Training Program in Wellington, Florida, and two USDF Junior Young Rider Clinics with Charlotte Bredahl and USDF Presi-



dent George Williams, however throughout those years things have not always been easy.

When I was first introduced to dressage I was still riding a hunter jumper pony who had quite an attitude and was not fond of dressage. In 2010, I began riding an Arabian mare who had a dressage background but was far from easy to ride. I competed this mare through Training Level and soon after I purchased a jumper pony named Toblerone, who was too spicy for kids and too small for adults to ride, but despite his large personality and opinions, we participated in two Winter Intensive Training Programs at Hampton Green Farm in Wellington, FL, received scores up to 70% at Second level and placed 5th Nationally in the FEI Ponies division. After our success in the FEI Ponies, I sold Toby and purchased a 4th level horse who I had hoped to move up to the FEI Junior Division with, however, he was always very difficult and borderline dangerous to ride. After a year and a half of extensive vet bills and frustration, we discovered he had ventral ankylosing spondylosis following a full-body scan at The New Bolton Center, spondylosis is very rare only 3% of horses globally have it, so we made the difficult decision to euthanize him after weighing all of our options. For the remainder of 2016, we searched high and low for a new partner and finally in September we found a mare who looked like a wonderful prospect for the FEI Juniors, but unfortunately, it did not work out. Luckily I was once again in The WIT Program and had the opportunity to try many horses each day in order to find another horse. At the end of February, I had the opportunity to try a Grand Prix horse named Al Forno, who I instantly fell in love with. I tried not to get my hopes up as I knew he would be too far out of our price range but his owner felt as if we were a perfect match and was willing to lower his price. Al is an incredible teacher and has completely transformed me as a rider, he is without a doubt my once in a life time horse. All of my Silver Medal scores were received on him and while they didn't come easy, I would not ask for it any other way and I cannot wait for the 2018 show season so we can continue to grow as a team.

Currently, Al and I train with Stephen R Hayes and are working to improve the solidity of the Prix St George to qualify for 2018's NAJYRCYoung Rider's division and move up to Intermediare 1. Eventually, I aspire to compete in the Grand Prix and receive my Gold Medal. My biggest hope (continued on following page.)

is to inspire young people to follow their passion and go for their goals. It's not always easy but, it's always worth it. There are many organizations that are willing to help young riders such as The Dressage Foundation, Dressage 4 Kids, USDF, Local GMO's and Region specific GMO's. I also want to impress upon young people to be grateful for every horse that comes into their world, no matter their cost, training level or breed, each and every horse has something to teach, from the spicy backyard pony to fancy Grand Prix horse, they all have a lesson for us as riders.

Old Business:

- 1. Our Recognized shows will take place on June 8-9, 2018.
- 2. USDF Convention:

Dinah Guarino will be our Delegate. Others attending will be Jane-Marie Law, Carol Morris, Bettina Wagner, and (maybe) Kathy Thode. Two important parts of this convention are the GMO and Region 8 meetings. If you have any issues that you would like to be brought to the attention of USDF please let Dinah know. (continued)

Kathy would like USDF to help us to recruit Junior/Young Riders.

Connie mentioned that there should be more/better recognition of riders who compete in Pas-dedeux and Quadrille classes, as these require a lot of preparation.

- 3. Jane-Marie discussed her attempts to get a USDF grant for a clinic. Apparently these grants can only be given if a clinic is with one of five listed trainers. Perhaps this is something else that can be discussed at the Convention.
- 4. Jane-Marie also reported that USDF will be bringing back a "Lower tier" show. Some people may remember the "Regional" shows that ran for a few years. These had some lesser requirements than the fully recognized shows. Details about this should be forthcoming at the Convention.

New Business:

1. Committee structure: we need to increase membership in all committees, and there needs to be a Chair for each, who is responsible for organizing and reporting on the work of the committee. A motion was made by Jane-Marie to reach out to the membership to form these committees; Carol seconded. Carried.

Two Ad Hoc committees were suggested: Working Equitation and Western Dressage. Jane-Marie moved and Bettina seconded the formation of a Working Equitation Ad Hoc committee. Carried. Bettina suggested that those interested in Western Dressage be invited to the October meeting. We will try to to organize a Working Equitation clinic with Suzanne Marshall at Connie O'Hearn's facility sometime this fall.

2. Jane-Marie asked each of us to describe what we are passionate about in order to help identify how each of us will be instrumental in moving the club forward.

Jane-Marie focused on her interests in the Recognized and Causal shows, and Working Equitation.

Jean described her interest in eventing. She thinks we need to do more for the eventing community in our area. She sees the greatest need as locating a site for cross-country schooling, as the Morgan's facility will no longer be available. She would also like to see more education about eventing.

Ginny, our Treasurer, is passionate about keeping us solvent, but also expressed interest in upgrading our eventing activities.

We diverged to a discussion of how to entice new members. Tina asked about the benefits of Club membership, and noted that we need to raise awareness of all the benefits of being part of our GMO. One issue is the time required to come to meetings. One alternative is to use technology such as Skype, so people can attend remotely. Carol suggested that we re-print the three-fold brochures that were made up a few years ago for distribution at local shops, events, etc. Jane-Marie will try to locate one.

Bettina moved and Jane-Marie seconded that people who cannot attend in person be allowed to use technology to attend via the internet. Carried. (continued)

Jean suggested that we offer an educational program along with each business meeting.

Jane-Marie asked that, as a result of work from now till January, each committee will have a specific event and date ready for discussion and approval at the January meeting. We can then publish a calendar of events for the entire year in our newsletter and other appropriate publications.

Connie's passion relates to her idea that dressage should be helpful for any horse, in any discipline.

Prin is interested in learning about what the Club does. She would like to get 4-H involved as the local Pony Club has dissolved. She will work with Connie on this.

Tina would like to maintain the energy level of the Club by offering many activities.

Cayuga Dressage and Combined Training Club Awards 2017

Your humble awards committee (whose motto is "We can honor whatever we want because we can!") has been busy in their hive of altruism thinking up new and better awards to delight and honor our members. But not all of the fun is ours alone! You get to nominate (and even self-nominate in some cases) the best, brightest and even most fool hearty. So, do 't let the sun go down on this e-mail being unanswered. Send your replies to Jane Marie Law, (jml16@cornell.edu), Karen Steffy (wonderpony92@gmail.com) or Kathy Thode (kthode3@gmail.com). All nominations due by October 15.

The awards needing nominations are:

1. Good Sportsmanship Award

This award was created to highlight the ideals and values of good conduct, civility, good role modeling and sportsmanship in our sport. An award is given each year to the club member who has consistently displayed the values of kindness to people and animals, in competition graciousness in losing or humility in winning, in everyday activities in the club and stable encouragement of others in their endeavors, and a willingness to serve as a positive role model for other people coming into the sport. This award is by nomination. Nominations for the award should be send to the awards committee no later than October 15. The awards committee will, with the assistance of the board, select the annual recipient, who will be honored at the annual banquet and in the newsletter with a feature article on her (or his) views of good sportsmanship. A cash prize of \$100 will also be awarded.

Nomination letters should include the person's name and a detailed description of why the nominator thinks this person is a good recipient. They should be received no later than October 15.

2. Spirit of Dressage Award

This award is given annually to a person 21 years of age or under (as of January 1 of the award year). The award is \$150, to be used towards advancement of educational goals. To be eligible for the award, the candidate must: 1) be a member in good standing in CDCT at the time of application, 2) be pursuing the art of dressage in a consistent fashion (though not necessarily competing), 3) complete a statement of purpose and submit one nominating letter from any club member or a trainer and submit these documents to the Board of Directors of the club no later than October 15.

Description of the award:

Dressage is a lifelong pursuit, and Cayuga Dressage and Combined Training wishes to recognize a young person who is representing the values and ethics of dressage as an art form: the quest for honesty, naturalness and harmony in one's dealings with his or her horse, the attention to the deliberate and careful development of the talents of the horse and 3) an emerging expression of these qualities of cultivation in one's own life. <u>Statement of purpose</u>: Please write a short stament (between 250 and 500 words, lone to two pages) describing your background with dressage, why you are attracted to this art and what this discipline has taught you. Please also indicate your future plans regarding your riding. Also ask one person, preferably a club member or trainer (but not a family member) who is familiar with your dedication to dressage to write a letter of support for you.

3. What Was I Thinking Award?

(Self-nominations possible, more than one award may be given if the humble awards committee deems it to be necessary) This award is designed to honor the person who took enormous risks this year and is not yet sure if they are worth it. Acts of sheer bravery, utter stupidity, fool-hearty enthusiasm and downright risky decisions are to be honored. A nomination must include a description of the behavior or action that merits awarding with all expense paid trips to exotic locations (other than the emergency room).

4. That turned out better than I thought award




